Tuition payments may be prepaid at any time. Payments are due on the designated due dates listed per the payment manner that you choose. If you decide to change your payment method, please contact the Parish Office. Payments made 10 days past the due date incur a late fee of \$20.00. For example if your scheduled payment is due on the 1st and you pay it on the 11th, \$20.00 will be added to the amount due.

Checks returned to Christ the King from your bank due to non-sufficient funds in the account would be charged a processing fee of \$25.00 as well as the late fee of \$20.00. If two checks are returned for non-sufficient fees (nsf), personal checks will no longer be accepted. Money orders will be required.

I understand that financial responsibility is assumed for the entire school year and that the tuition is due and payable according to the terms specified; **that no report or transcript will be furnished until all financial obligations to the school have been fulfilled; and that the School reserves the right to discontinue services to the student if tuition payments become seriously delinquent.**
